Manipur state Government na "War on Drug" touriba asidi "Paper Tiger" haibaduni. May 3 dagi nouhounana India leingakna thokhanba "Proxy War" asida State Force sing asi karisu touban ngamjade. Asumna pangal yaojadra mamingta ngairaba State leingak asina Indian gi Regular Army, Para Military, Business Tycoon, Politician asina chingba kayana thoujilliba (Sponsor touriba) amadi hakthengnana saruk yariba "Drug ki Politics" asida State Government ki "War on Drug" asi "Maya Yaodre, Mayak Chamle".

May 3 gi Proxy War matungda Drug sing Manipur faoduna puramba adu Mizoram lomda chatkhre, Manipur da changlaktre haina louruba yadri maramdi houjik Manipur manungda fangliba mayaikaba chinjak asi asukki matik marang kaikhre. Mayam asi kadaidagino? Puppet Government gi "War on Drug" kadaida lotkhre?

Hassan kouba leikhidra Md. Habbibur gi macha Lilong Chingjao da leiba meei asi faba matamda mafam adugi meeoising aduna thomjillaktuna pairiba khutlasing munnaba hotnarakpa matamda ahanbada nongmei matol nongthakta onkhatlaga kaptuna mayam changlaktanaba hotnakhi. Masifaobada henjillakpadagi faraba mee adu thadoklamlaga esa kanjanaba haiduna chenthorakpada eikhoigi meeoising tamna nongmei kapsillakpa hourakkhi.

Thoudok asigi matungdagidi asigumba thoudok thorakpada "Defensive Measures" lounaba party gi oina "Standing Order (SO)" ama thamkhi. SO asigi matung inna Jan 1 gi numidangda

Lilongda thokkhiba thoudok asida eikhoisu esa ngakthokchanaba nongmei kaplakliba adu tamna nongmei kapkhi amasung mafam adudagi nanthoktuna chenthorakkhi. Eikhoigi meei singna tonglakpa Gypsy sing mafam adugi meeyamna mei thaba hourakkhi. Meina chakpa matamda Gypsy da yaoba nongmei maru, 40 mm Grenade amadi 60 mm Mortar Shell sing adu pokhaikhi.
